Things to know about the Health Insurance Marketplace

IF YOU DON'T HAVE HEALTH INSURANCE, THE Health Insurance Marketplace® can help you find coverage that fits your needs and budget. When you fill out a Marketplace application, we'll tell you if you qualify for:

*Private insurance plans. You may qualify for savings based on your household size and income.

*Medicaid or the Children's Health Insurance Program (CHIP). These programs cover people with limited income, disabilities, and other circumstances.

*If you're eligible for job-based insurance, you can consider switching to a Marketplace plan. But you can't be enrolled in a job-based plan and a Marketplace plan with savings at the same time.

*If you experience certain life events (like moving to a new state, getting married, having a child, or losing health coverage), you may qualify for a Special Enrollment Period to enroll in or change your Marketplace plan outside Open Enrollment. You can apply for Medicaid and CHIP any time.

Southeast Healthcare, Inc. offers Navigators to assist Ohio consumers with the process. A Navigator is an individual or organization that's trained and able to help consumers, small businesses, and their employees as they look for health coverage options through the Marketplace, including completing eligibility and enrollment forms.
